Background:

The Supreme Court by its decision dated 22 November 2024 in suit no. SC/1/2008 between the Attorney General of Lagos State & Ors and the Attorney General of the Federation & Ors declared the National Lottery Act 2005 unenforceable in all states of the Federation except the Federal Capital Territory. The basis for the court's decision is that states, and not the Federal government is empowered by the Constitution of the Federal of Nigeria 1999 (as amended) to legislate on gaming activities within the states. It is important to note that prior to the Supreme court's decision, several states had begun taking steps to regulate gaming activities within their jurisdiction. Gaming regulatory activities in the states are at varying levels of maturity from absolute prohibition to comprehensive regulatory frameworks and from sector-specific state regulators to licensing activities by state ministries of finance and revenue service. Due to the unresolved fisticuffs between the federal legislator and the state regulators/government, the ecosystem remained unclear until this decision, we expect to see more state gaming regulations.

The live repository presented below tracks the state of the play with respect to gaming regulation across the 36 (thirty-six) states of the federation and the Federal Capital Territory. Notably, for some states, we experienced difficulty in accessing or identifying the laws or regulations applicable to the gaming sector within their jurisdiction. However, we aim to continually update the information in response to changes in the circumstances. Additionally, we anticipate that based on the Federation of State Gaming Regulator's expression of commitment to the Universal Reciprocity Licensing regime (an innovative system designed to simplify licensing processes across states, allowing operators to operate smoothly while maintaining each state's autonomy), there may be efforts towards synergising the licensing framework across states within the federation. This and similar other changes to the sector may also result in further updates and changes to the information on this tracker.
